

## Price list (document supply service and royalties) of the photographic library

This price list is based on the legislation in force :

- Ordinance n° 2016-307 of March 17<sup>th</sup> 2016, which codifies the provisions on the use of public information in the *code des relations entre le public et l'administration* (for example, Article L324-2)
- Law n° 2016-1321 of October 7<sup>th</sup> 2016, *pour une République numérique*
- Decree n° 2016-1617 of November 29<sup>th</sup> 2016, on the categories of public information which may be subject to the payment of royalties
- Decree n° 2016-1036 of July 28<sup>th</sup> 2016, on the principle and terms of determination of royalties to use public information

### 1. Terms of payment

Payment is made by cheque or by money order, after the invoice has been issued. Under no circumstances will bank charges and taxes be imputed to the Observatoire de Paris. No invoice will be issued under 30 €.

### 2. Document supply service

The readers are allowed to take pictures of the documents as long as they comply with copyright and preservation requirements. Pictures are made without flash or contact with the document.

The online images from the collections of the photographic library can be downloaded for free.

The Library provides the readers from the Observatoire de Paris with pictures of its collections for free. This document supply is granted for private or non-commercial public use.

The Library reserves the right to refuse some orders for the following reasons: technical possibilities, human resources, compliance with preservation and copyright requirements, among which prior permission from the copyright holders.

### 3. Royalties

The readers are free to use the digital documents for private or non-commercial public purposes.

The use of documents for commercial purposes is subject to prior approval from the Library (see commercial use licence), and leads to the payment of royalties and, when relevant, to the donation of a copy of the monograph or periodical.

Specific agreements between the Observatoire de Paris and institutional or trading partners can be signed for some projects, for example for co-publishing projects.

In some instances, no royalties will be charged for commercial use, if the commercial use illustrates current scientific and cultural topics and enhances the image of the Observatoire de Paris.

When the Library does not hold the copyright, the user is notified and must contact the author or the right holders.

In accordance with the legislation in force, the royalties price is based on the costs of collection, production, provision, dissemination, preservation, and acquisition of the intellectual property rights, averaged over the last three years. Presently, the royalties price is:

In the event of a publication, the licence is granted for one edition. In case of reprint or update, there is no additional payment. Every other new edition leads to a new licence. In the event of an exhibition, the licence is granted for the duration of the exhibition.
